A. Chief's Report

Chief Thompson made the following comments:

- Total incidents in December 189, EMS 82
- EMT expanded scope training will be held February 11-13 and run by our CQI Coordinator, Cathy Dooyes.
- Fire courses S230/S231 courses will be hosted by RAFD. These mandatory will assist those engaging in the Captain's promotional process.
- PFD and RAFD training officers have met and begun merging training priorities as well as scheduling of these events.
- Training Officer Coordinator position funded by the County will be posted this week and applications will be welcomed.
- Probationary testing for nine and 12-months continues.
- The Engineer's academy continues progressing well and moving towards the final evaluation. We are moving towards appointing two full-time engineers currently being held by part-timers.
- Annual apparatus maintenance and SCBA checks are underway by in-house techs, saving the district money.
- Chief Thompson is working with the county on a proposal for the VFCs and once this is completed, he will present to the Board for evaluation.

D. Firefighters' Association Report

Engineer Brian Sweet noted that the Association has received just under \$2,000 in donations, with \$1,000 alone from Anna Weihman. \$500 of this donation will go to

Engineer Sweet also commented the Association is putting money towards helping buy new station beds for staff. The Crab Feed is on January 26th. A thank you to the community is being worked on with ideas of making the July breakfast free or hosting a pasta feed. The 5th Tuesday is going to be held on the first Tuesday in February. This will coincide with our monthly Association meeting.

Mr. Hemmendinger said that we have donated some crab feed tickets to the major donors for helping the district with the passing of the ballot measure and he hoped this was the same across the board. Captain Bernal said that we do not release the names of whom we give the comp tickets to, but there were enough tickets to go around to those who donated. The comp list was revised this year and the Union bought an addition six tickets to hand out.

E. Firefighter's Union Report

Captain Bernal noted that on December 26th, Captain Larry Martinez retired. The Union decided to put acting captains in his position for the next two months to give them some experience. We hope to fill this position after the two months. The Union would also like to hire and fill the two open Engineer positions before we get the Measure W money. The Union members hope the Board will consider this.

Mr. Proteau commented that he still has not received the warranty information on the roof from the contractor but he will follow up with him. We continue to hold the retention money until this process is completed.

Mr. Hemmendinger commented that he felt Mr. Gadoua had a good point last month about taking a step back before asking SSU again for funding. He wondered if Mr. Gadoua had any time to pursue this, hopefully creating some friendly relationships and see if we can draw up a written proposal. Captain Bernal commented that he has some information from the CPF as well that he can share with Mr. Gadoua. Chief Thompson offered his time to attend any meetings Mr. Gadoua can set up with SSU.
